Good Morning,

Based on a recent Permit Request, the ACC suggests that the Board consider a revision to the Fee Structure for Permits. There appears to be a gap between "Major New Structure" and a Carport. We recommend adding "Out Building" (ie: Shop Building) at \$100 Permit Fee, \$200 Fine, and \$80 Penalty. There are considerable items to consider with these Structures such as Location, Style, Height, Driveway, Drainage, and Septic.

The current Fees are:

	Permit Fee	Initial Fine If No Permit Approved Before Construction	Monthly Fine While Construction Continues Without Permit
Major Construction (Examples) - New Site Home - New Mfg Home - Replacement Mfg Home Add:	\$200 \$100	\$500 \$200	\$100 \$80
Minor Construction (Examples) - Shed / Barn - Carport - Pool - Porch	\$50	\$100	\$75
